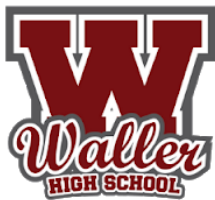

GENERAL

Waller ISD ONLINE (WISD Online) is available to all enrolled students (PreK-12th Grade) for the 2020-2021 school year due to the lasting impact of COVID-19. It includes a framework that encompasses a schedule in which students will be able to engage in instruction delivered virtually through technology. Instruction will be designed around the schedule/daily minutes required by the Texas Education Agency (TEA). Google Classroom will be utilized to provide the platform for learning and management of instructional materials.

WISD Online will follow the [Waller ISD 2020-2021 School Calendar](#).

7/27 Update: ALL WISD students will start the school year on Aug. 24 using WISD Online. At this time, our hope is that we will be able to provide the WISD On-Campus option starting Sept. 14, however this date is dependent on state and county officials and requirements from the Texas Education Agency (TEA). [Parents/guardians are encouraged to update contact information in Skyward to directly receive WISD updates.](#)

STUDENT DEVICES

WISD will loan and distribute student devices to enrolled students. Chromebooks are guaranteed for students in grades 1-12 and students in PreK/Kindergarten may receive an iPad based on need.

GENERAL INFORMATION

- If a student is still in possession of a Chromebook that was used for Summer School, they will keep that device through the 2020-2021 school year.
- When a student is issued a device, it is their responsibility for the entire school year. If a student switches from WISD Online to WISD On-Campus, they will use the same device whether at home or at school.
- WISD student devices are on loan. Families are expected to return devices at designated times/locations at the end of the school year.
 - If a student is withdrawn during the school year, devices must be returned to the WISD Technology Building (1914 Key Street in Waller) during regular business hours (Mon.-Th. 8 a.m.-4:30 p.m. | Friday 8 a.m.-4 p.m.)
- Families will be held responsible for the cost of devices and accessories that are not returned.

A DAY IN THE LIFE OF WISD ONLINE

We know you have questions as to what a day in the life of WISD Online might look like. The level of rigor, workload, time commitment, and timing of online classes will be vastly different from the Education Outreach Program that was used in Spring 2020. Through WISD Online, teachers will personalize learning experiences and meet students’ unique needs, just as they would if they were face-to-face with learners in a school building.

- Teachers will create daily lessons and meet with students at designated times to provide instruction as well as structured independent learning. Video instruction will be posted in Google Classroom for students to view at any time.

- Google Classroom is the designated learning platform that all PK-12 students will use to connect to their courses for WISD Online.
- Students will be expected to be engaged via Google Classroom (daily progress via student-teacher interaction and completion of assignments) daily.
- Student engagement will directly correlate to student attendance.
- Some students may have the opportunity to attend live lessons with teachers according to grade level and course.
- Daily learning schedules will be provided by teachers to help students and families to know what to expect and plan accordingly in order to meet learning and attendance expectations.
- Grading for all courses will follow the same grading policy as the courses in WISD grading guidelines. According to TEA guidance, the grading policies for online instruction must be consistent with the grading policies for on-campus assignments.
- WISD is required to provide Texas Essential Knowledge and Skills (TEKS) curriculum to all WISD Online and On-Campus students.

ATTENDANCE

- 5 days of attendance (M-F) is required.
- Daily, trackable student attendance/engagement exists to ensure curricular progress in online learning.
- Curricular progress and attendance will be measured through:
 1. Completion of [live and/or independent lessons](#) (activities, assessments, projects) on a daily basis;
 2. Attending [live lessons](#) for tutoring, intervention, and/or enrichment; **or**
 3. Daily student-teacher interaction.
- Students who have not met at least one of the three requirements above will be marked absent at 3:30 p.m.
- Absences can be resolved if the student engages in daily learning assigned by their teachers by 11:59 p.m. each day.
- Parents and students will receive absence notifications via Skyward after 5 p.m. each day and will be reminded of the opportunity to resolve that day's absence.
- Assignments will appear in Google Classroom on a daily basis.

IMPORTANT NOTE: If a student is engaged in WISD Online and completes the entire weeks' worth of learning activities on any single day and does not login for the remainder of the week, he/she will be marked "present" on the day they completed work only and counted "absent" all other days.

- State law and WISD Policy requires students to attend at least 90% of their classes to receive credit and be promoted. Remote attendance will count in the same manner as on-campus (face-to-face) attendance in satisfying this requirement.

LEARNING MANAGEMENT SYSTEM

- Google Classroom will be used to support all students utilizing WISD Online to organize assignments, boost collaboration, and foster two-way communication.
- WISD has customized Google Classroom for students by level.
- Zoom will be used for all [live instruction](#).
- Student entry to Zoom sessions will be monitored and approved by teacher hosts.
- Teachers will provide training to students on how to use these digital tools.

INSTRUCTION TYPES

Students will have opportunities for daily, live instruction with certified teachers, as well as periods of daily self-paced independent learning. WISD Online will include **Independent (asynchronous) Instruction** and **Live (synchronous) Instruction**.

- **Independent (Asynchronous) Instruction:** Curricular experience where students engage in the learning materials on their own time, interacting intermittently with the teacher via the computer or other electronic devices or over the phone. Lessons will be provided to be completed at the student's own pace each day. **Teachers will be in contact with each student and their family to communicate personalized learning schedules.** Review [Attendance](#) requirements.
- **Live (Synchronous) Instruction:** Two way, real-time, live instruction via Zoom between teachers and students, through the computer or other electronic devices or over the phone.

- **Elementary Live:** Times will be determined by the classroom teacher. Teachers will meet with students in small groups. Students will NOT be penalized for missing a scheduled Zoom session as long as they meet other [Attendance](#) requirements and complete assignments as scheduled by the classroom teacher. Video instruction will be posted in Google Classroom for students to view at any time.
- **Secondary Live:** Times will be determined by the classroom teacher. Students will NOT be penalized for missing a scheduled Zoom session as long as they meet other [Attendance](#) requirements and complete assignments as scheduled by the classroom teacher. Video instruction will be posted in Google Classroom for students to view at any time.

DAILY INSTRUCTIONAL MINUTES

The minutes in this section do not include transition times, lunch, advisory, and/or recess. **The times in which a WISD Online student completes his/her daily instruction are generally flexible, however daily attendance and engagement is required.** Reference [Attendance](#).

Recommended time for needed student interventions is an additional 30-50 minutes per day. Teachers will discuss interventions with families as needed.

ROLES OF TEACHERS

- Participate in district-level content teams and help to develop instructional plans for online learning.
- Attend grade-level and/or content-level planning meetings with other teachers, literacy and math coaches, and instructional facilitators.
- Create and maintain schedules for online instruction and communicate regularly with families.
- Maintain their Google Classroom, post assignments, and use the results to plan instruction.
- Attend all required professional meetings, including professional development, ARDs, 504 meetings, etc.
- Work with the Special Education department to assure all needs and IEP goals are met.
- Administer assessments to determine student mastery.
- Analyze assessments with instructional coaches to monitor student progress to make decisions regarding instruction and intervention.
- [Track daily attendance.](#)
- Conduct tutoring, interventions, and make student contact during [independent time.](#)
- Submit lesson plans with detailed information that is particular to individual classrooms, including small group instruction, intervention schedule, accommodations, etc.
- Be accessible during stated office hours.
- Check-in with students and families as needed.
- Maintain a parent communication log and provide students and parents with timely feedback.
- Build positive relationships with students and families.
- Be flexible, responsive, and positive with the understanding that students and families will be affected by the closure in different ways.

ELEMENTARY TEACHER OFFICE HOURS

- Teachers will work diligently to assist students and families during scheduled office hours and when possible during school day.
- **Teacher office hours will be held during their regular scheduled planning time. Teachers will communicate this time with their families.**
- Families and students who need assistance outside of the regular school day and designated office hours should contact the teacher via Google Classroom, or other method specified by the teacher.

JUNIOR HIGH & HIGH SCHOOL TEACHER OFFICE HOURS

- Teachers will work diligently to assist students and families during scheduled office hours and when possible during the school day.
- Teachers will work with individuals to schedule conference times before or after regular school hours or during their scheduled conference period.
- Students may send messages to their teachers via Google Classroom at any time and teachers will reply as soon as possible.
- Families and students who need assistance should contact the teacher via email, Google Classroom, or other method specified by the teacher.

ROLES OF STUDENTS & PARENTS/GUARDIANS

- **STUDENTS**

- Follow the designated schedule communicated by their campus.
- As developmentally appropriate, take responsibility for advocating for themselves.
- Turn in school work at the direction of their teacher(s).
- Actively participate in lessons with a positive attitude and willingness to learn.

- **PARENTS/GUARDIANS**

- Facilitate academic support and encouragement as a learning partner to motivate and guide your child throughout the school year in your role as a learning coach.
- Monitor and ask for evidence that your student is on track with assignments and coursework.
- Check Google Classroom courses frequently.
- Provide your student with assistance on their day-to-day activities with the exception of designated independent work.
- Assist in supporting your student's needs by establishing and managing the daily schedule communicated by the teacher and the campus.
- Consider creating a designated learning space for your student at home to learn comfortably.
- Maintain communication with your student's teacher by phone, email messages, and/or online meetings to create a learning partnership.
- Help your student own their learning. Provide support and encouragement, and expect your student to do their part.
- Struggling is allowed and encouraged! Don't help too much. Becoming independent takes lots of practice.

COMPETITIVE STUDENT ACTIVITIES

(Grades 7-12 ONLY)

- Students who are participating in WISD Online may participate in competitive student activities (ie. athletics, band, etc) as allowed by state and local authorities, UIL, TEA, and/or WISD On-Campus guidelines and protocols.
- Students who are participating in WISD Online may choose to attend the activity during the school day and after school. Those choosing to participate in Competitive Student Activities MUST provide their own transportation to/from the selected activity and be dropped off/picked up promptly from campus-designated locations as allowed by state and local authorities, UIL, TEA, and/or WISD On-Campus guidelines and protocols.

SPECIAL CONSIDERATIONS

(Special Education, CTE, GT, etc.)

- Students who receive services or accommodations through [Special Education](#), Gifted and Talented, 504, multilingual services, or others will continue to receive the support and services as outlined in each student's applicable plan.
- As appropriate, secondary students (grades 6 - 12) will have access to [Career and Technical Education](#), Dual Credit, and Advanced Placement through WISD Online. Some courses/programs may require admission and on-campus activities throughout the semester.
